Snow and Inclement Weather Policy Reminder

As we are seeing more snow on those mountaintops, it's as a good of time as any to revisit Serendipity closure protocols in the event of inclement weather and heavy snow.

In preparation for closure due to heavy snow, when a storm or inclement weather and/or unsafe road conditions due to weather is predicted, Serendipity will not close unless the local paratransit company/AnchorRide closes. Homes/families that do not utilize AnchorRides for transportation will be contacted to ensure facility closure is shared. As always, keep safe out there.

Love Your Feet. Denise Ramp is a nurse practitioner who provides foot and nail care services where the client resides and at Serendipity. The goal of Love Your Feet is to foster a client's **mobility, comfort and dignity** in maintaining independence.

Clients pay Denise directly. She does not bill insurance. She will provide an invoice of care given to a client to submit to insurance for possible reimbursement.

The service fee schedule is:

- \$150.00 for the initial assessment and foot and nail care
- \$120.00 for subsequent annual assessments and foot and nail care
- \$90.00 for maintenance foot and nail care visits
- \$30 for follow up on concerns
- \$10.00 for individual home visits. This fee is waived if two of more clients are seen at the same site.

Love Your Feet has a **"pay what you can"** policy to ensure all who need foot and nail care services can access care.
